The Association of Military surgeons of the United States, also known as AMSUS, the Society of Federal Health Professionals ("AMSUS", "we," "us" and "our") respects individual privacy and values the confidence of our members and visitors of this website. This Privacy Policy sets out the privacy principles that we follow with respect to the collection, use, and disclosure of information that you may provide through AMSUS' website, <a href="www.amsus.org">www.amsus.org</a> (referred as the "website"). # PRIVACY POLICY:

#### COLLECTED INFORMATION

It is AMSUS's general policy not to collect user's personally identifiable information from the website. However, when users join AMSUS as members, create a visitor account, donate to AMSUS, subscribe to AMSUS publications, access AMSUS online store, register to attend AMSUS events, or otherwise contact AMSUS by email or the website's designated contact section, in order for AMSUS to respond, users may be asked to provide personal information from which you can be identified, such as your name, date of birth, postal and e-mail address, phone number, and credit card information. AMSUS only collects personally identifiable information you voluntarily submit to AMSUS.

When you terminate your membership, subscription, or AMSUS website account access, AMSUS may continue to share information about you according to our legal and regulatory requirements. We will use the information you provide us solely for the purpose of providing you with information that AMSUS believes may be of interest to you, providing you with information and materials you have requested, administering our relationship with you, and for internal business purposes such as AMSUS research and development projects.

### SHARING AND DISCLOSING INFORMATION

We will share your personal information with third parties only in the ways that are described in this Privacy Policy.

AMSUS Membership List: AMSUS contracts with a third party marketing vendor, which makes AMSUS' membership list available to organizations whose products and services may be of interest to our members. AMSUS members may opt-out of being included on the foregoing membership list.

AMSUS Conference and Meeting Attendee List: the list of conference and meeting registrants is provided for one-time use to authorized exhibitors for that one conference/meeting. Attendees may opt-out of being included on the foregoing list at the time of registration.

AMSUS Agents: your personal information may be used within AMSUS or by a company acting as an agent of AMSUS for operational support purposes, including but not limited to event registration, system

maintenance, and mail processing. AMSUS may also use this information internally for performing marketing studies, research projects, and program development in support of AMSUS mission purposes.

AMSUS does not otherwise share your personal information with third parties for their promotional use or for marketing purposes.

Credit Card Information: AMSUS does not disclose credit card account information provided through the Website. When users choose to pay using their credit cards, AMSUS submits the information needed to the appropriate clearinghouse through secure sites to conduct the transactions.

Notwithstanding the foregoing, AMSUS may disclose your personal information as required by law or as needed in legal proceedings when AMSUS believes in good faith that disclosure is necessary to protect our rights, protect your safety or the safety of others, investigate fraud, or respond to a government request.

In addition, in the event of a merger, acquisition, or any form of sale of some or all of our assets to a third party, we may also disclose your personal information to the third parties concerned or their professional advisors. In the event of such a transaction, the personal information held by AMSUS will be among the assets transferred to the buyer.

## **Cookies and Web Beacons**

Cookies and web beacons are files that contain information created by a web server that can be stored on a User's hard disk for use either during a particular session ("per-session" cookie) or for future use ("persistent" cookie). AMSUS uses cookies only to facilitate automated activity, store and track AMSUS ID numbers, session status, and navigation patterns. Cookies are not used to disseminate significant information about Users over the Internet or to analyze any information that Users have knowingly or unknowingly provided. When a user registers, the system will ask whether the user approves of the attachment of a cookie. Users may instruct their Internet browsers to opt out of accepting a "persistent" cookie and rather accept only a "per-session" cookie, but will need to login each time they visit the site to enjoy the full benefits.

You can choose to accept or decline cookies. Most web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. However, if the User declines the attachment of any cookie, the user may not have access to the full benefits of the Website. Registration enables the site to better determine members' interest areas and provide the most relevant information.

Third-party cookies and/or web beacons are cookies or web beacons provided by our technology and/or advertising partners. Any third-party cookie or web beacon that we authorize for use on the Site only collects that information described below for the same stated purposes as if we were directly collecting the information. For a third-party cookie or web beacon, the third-party will have access to the collected information in order to provide us with information or services to enhance the performance and functionality of the Site.

The cookies and web beacons we use collect non-personally identifiable information about users of the Site, including: browser used to access the site, date and time, the URL of the page being loaded, users who have visited a particular website(s), any previously assigned cookie identification (a unique identifier assigned to a user to identify repeat visitors), browser window size, the geographic location of the user, device and operating system used to access the Site. The information we collect from these cookies and web beacons is used to determine information about a user's visit to our Site, including the number of visits, average time spent, pages viewed, navigation history through the website, and other statistics.
