



2022 Abstract Submission Guidance

Meeting Theme: Healthcare Transformation Starts with Medical Education and Training

As AMSUS celebrates its 130th anniversary, the Society of Federal Healthcare Professionals is honored to continue the tradition of providing the premier neutral platform to share innovation and advancement of medical techniques, treatments, and technology to propel overall care for the health and wellness of all. Collaborations and content are provided by healthcare leaders, clinicians, researchers, allied healthcare professionals, and students of the health sciences and hail from the uniformed services, federal agencies, civilian sector, industry, academia and international coalition partners.

***IMPORTANT!**

****Active duty military personnel and civilians with the Defense Health Agency (DHA) must have their leaderships pre-approval to submit. A sample of the online submission form has been provided at the bottom of this guidance document for planning purposes; the **online** form available after June 1, 2021 must be completed as the formal submission.

All presenters or panel members named on the submission will be required to complete the following:

1. Establish or update your **profile** with email address, service or agency affiliation and rank/civilian status, professional credentials, business address, phone number where you can be reached
2. Upload a current Curriculum Vitae (**CV**) or resume
3. Complete the online **Continuing Education Agreement and Disclosure** Forms (can be provided in pdf format if preferred to read in advance or submit to AMSUS directly. The Disclosure will become active/visible after the abstract content is complete)
4. Additional presenters can be added following the initial content submission form with the first presenter's information.

Prepare Ahead:

For the abstract submission you will need to provide the following:

- Title of the presentation (20 or fewer words – Do Not Capitalize all text, only first letter of words)
- A one paragraph summary describing your presentation; approximately 500 words or fewer
- 3-5 outcomes (Following this presentation, **the participant will be able to...**)

- Select the most appropriate track category for your presentation. *(Reviewers and planners will take this into consideration, however, if selected it is not a guarantee the same track assignment will be possible)*
- *AFTER the review and acceptance process, ten (10) Post test questions with multiple choice answers – ONLY needed if your presentation is accepted as a virtual session, NOT Live/In-person sessions!*

Breakout Topics: The following topics will be used as a guide measure for presentation acceptance with the express interest to share successful ethical, and optimal professional healthcare practices, research findings and outcomes; keeping in mind the direction of “One Health” and collaborative and integrated care:

1. **Surgical/Traumatic Injury/Clinical Care** - These clinically relevant presentations encompass the entire spectrum of care delivered by physicians, nurses, allied health personnel and healthcare extenders. May include advances in the delivery of healthcare, latest research in trauma and casualty care, as well as the increasing complexity of healthcare administration and business operations while providing leading edge solutions in areas such as: health information technology, medical logistics, the business of healthcare, talent management and shared services, policy & practice electronic health records, drones, artificial intelligence, augmented reality, 4D Bio, regenerative treatments, medical ethics, prolonged casualty care, COVID-19 response and management. Surgery specific topics may include overcoming the inter-conflict gap in maintaining surgical skills with training and/or virtual education for surgery training benefits and downsides.
2. **Medical Education and Training** – These presentations should focus on new approaches, technologies and innovations in medical education, experiences and suggestions for didactic and clinical training during a pandemic, new content in medical school curriculums, One-Health discipline, CME and/or opportunities for mentorship, impacts on education/training from COVID-19. Training focused presentation may focus on use of VR/augmented reality.
3. **Psychological Rehabilitation** – These presentations should focus on cognitive and psychological disorders due to traumatic injury, addiction, situational trauma, transitional care following active duty, virtual assessment tools, and assessing the impact of COVID-19.
4. **Public Health** - These presentations should focus operational readiness as it relates to health promotion and wellness, occupational health, public health, dentistry, preventive veterinary medicine, preventive medicine, educational impact on vaccine hesitancy, public health baseline training for healthcare professionals, and/or environmental health. COVID-19 related operational issues; force health protection pivots; changes to nursing practice/ICU care, etc.
5. **Global Health** –These presentations should be focused on collaborative, population-based, trans-national health promotion. These presentations may discuss health concerns that cross country borders and may include coordination of care, prevention of illnesses, and treatment to sustain health as well as training of medical forces/force sustainment and/or leading during a changing healthcare landscape.
6. **Pharmacy and Pain Management** –These presentations will focus on best practices and advances in pharmacological management and treatments. Discussions may include opioid topics, addiction, alternative pain management, tele-health and prescription management.
7. **Non-CE – Industry-based topics** – Presentations that are relevant to healthcare but that contain industry proprietary content or do not meet CE/CME accreditation criteria.

AMSUS will accept abstracts through an online abstract submission system for all presentations, including podium and poster **1 June – 4 October 2021**.

Options of in-person OR virtual presentation will be a required selection in the abstract submission process. A limited number of submissions will be selected for the in-person meeting at the Gaylord National Harbor. All others will be offered a virtual, pre-recorded position.

Podium presentations will be based on a **minimum of 60-minute sessions to meet CME/CE requirements**. Contact Lori.Lawrence@amsus.org for other time block requests.

Posters will be presented virtually only.


